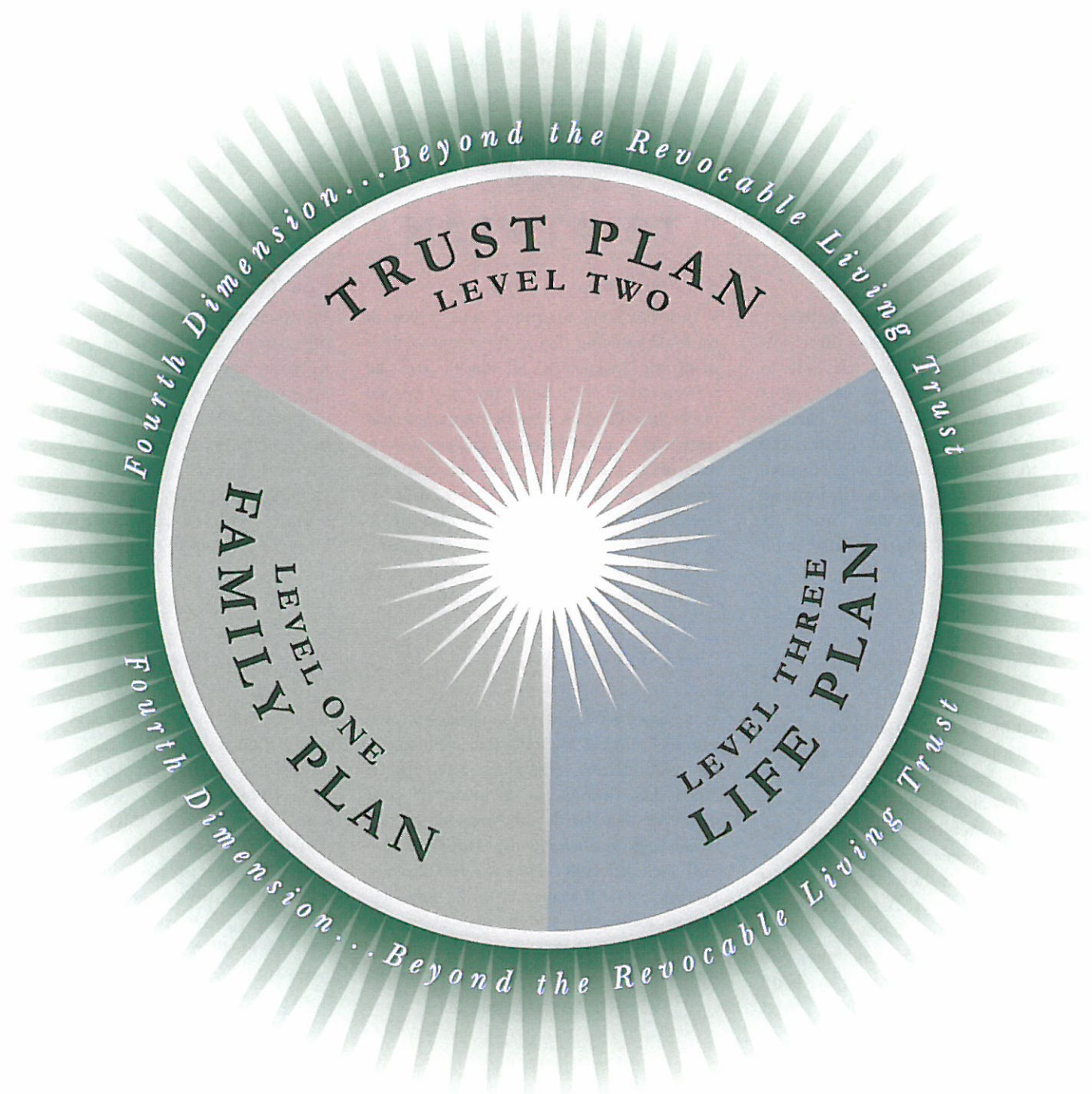

This plan allows the family to designate who will receive their assets at death and is appropriate for a family who has not yet accumulated assets which would need long term protection.</p>	<p><b>FOR THE FAMILY WHO ...</b> Wants the total assurance and peace of mind of knowing that in the event of their death or incapacity, all assets will be transferred to heirs, including any Special Needs beneficiaries, with the most ease and convenience possible in the privacy of our own office and thereby avoid the time and expense of the Probate Court process. Clients choosing this plan may also opt to protect their beneficiary's inheritance from creditors, lawsuits, spouses, estate taxes and the loss of government benefits.</p>	<p><b>FOR THE FAMILY WHO ...</b> Wants to protect the family home and other assets in the event of a potential nursing home stay.
